

**DODGE HORSE POWER SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.**

The Dodge Horse Power Sweepstakes (“Sweepstakes”) is sponsored by FCA US LLC (“Sponsor”), 1000 Chrysler Drive, Auburn Hills, MI 48326 and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on November 5, 2019 at 12:00 PM Eastern Time (“ET”) and ends on December 9, 2019 at 11:59:59 PM ET (“Sweepstakes Period”) and consists of five (5) entry periods (each an “Entry Period”) as outlined in the chart below:

Non-winning entries will carry **not** forward into subsequent Entry Period drawings. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry and hold a valid driver’s license. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, and where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit [www.dodgehorsepowerchallenge.com](http://www.dodgehorsepowerchallenge.com) (“Website”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Entrant must

then follow the links and instructions to answer a trivia question (“Trivia Question”). There will be one (1) new Trivia Question on each Entry Period start date for a total of five (5) Trivia Questions during the Sweepstakes Period. Each Trivia Question will have eighty-five (85) possible multiple-choice answers. Entrants can reduce the number of possible multiple-choice answers by entering a hashtag (“Hashtag”). Hashtags will be available on the Dodge Twitter page (found at <https://twitter.com/Dodge> or @Dodge) and the Dodge Instagram page (found at <https://www.instagram.com/dodgeofficial/> or @Dodgeofficial). For each Hashtag entered, answers will be removed from the presented possible multiple-choice answers to the Trivia Question for that Entry Period (see chart below for a breakdown of how many answers will be narrowed down). An entrant may enter one (1) Hashtag per calendar day and no more than five (5) Hashtags total per Entry Period. Entrant will receive one (1) entry into the Sweepstakes for the applicable Entry Period upon correctly answering a Trivia Question. If entrant does not correctly answer the Trivia Question he/she will not receive an entry into the Sweepstakes.

Creation of an Instagram account requires a contestant to agree to Instagram’s Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter or Instagram.

**Entry Limit:** There is a limit of one (1) entry per person per Entry Period. If more than one (1) entry per Entry Period is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, will be disqualified and not be eligible to win a prize. A “day” is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on November 5, 2019 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

**5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

- A. Prizes (5 total; 1 per Entry Period):** Each prize is Special Edition 2019 Dodge Challenger SRT® Hellcat Redeye (specific features and/or options, to be selected by the Sponsor in its sole and absolute discretion) (“Prize”). No more than five (5) Prizes (one [1] per Entry Period) will be available in the Sweepstakes. The ARV of each Prize is \$97,000.
- B. Total ARV:** The total ARV of all Prizes is \$488,000.
- C. Odds of Winning:** The odds of winning a Prize depend on the number of eligible Sweepstakes entries received during each Entry Period during the Sweepstakes Period.
- D. General Conditions:** Prize is awarded in “as-is” condition, subject to any warranty provided by Sponsor. Any vehicle upgrades, aftermarket additions, options or other elements beyond the model details provided in these Official Rules will be the sole responsibility of the winner, in the Sponsor’s sole and absolute discretion. Winner must take delivery of his/her Prize, at his/her own expense, within 45 days of notice of availability of a Prize from Sponsor at a Dodge dealership selected by Sponsor based on proximity to winner’s residence or the Prize may, at the Sponsor’s sole discretion, be forfeited. Prize vehicle details and availability are subject to change and will be selected by Sponsor at its sole discretion.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
